ADRs Reporting Status December-2022

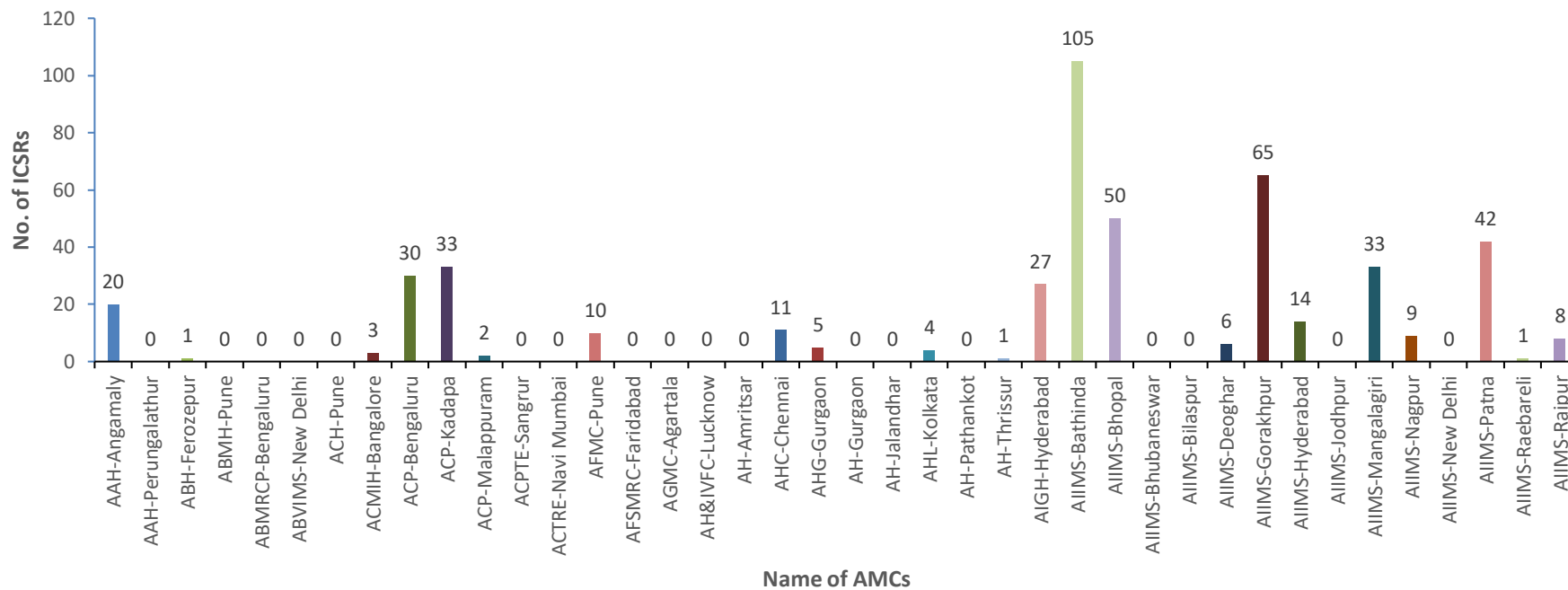
