**Indian Pharmacopoeia Commission (IPC)** is an autonomous Institute setup under Ministry of Health and Family Welfare, Govt. of India. IPC promotes the highest standard of drugs for use in humans and animals within practical limits of the technologies available for manufacture and analysis.

The Indian Pharmacopoeia Laboratory is a NABL accredited laboratory as per ISO/IEC 17025:2017 & PT Provider as per ISO/IEC 17043:2023 in chemical and biological disciplines. IPC has been accredited as Reference Material Producer as per ISO 17034:2016 and also a WHO pre-qualified laboratory.

IPC is conducting PT Round 02/2024 (Simultaneous Scheme: PT/IPL/02/07/24) for Drug & Pharmaceuticals in Biological discipline, in the month of July. In this PT round the following parameters will be considered for testing and evaluation of results:

- ◆ Discipline – Biological
- ◆ Group – Drug & Pharmaceuticals
- ◆ Parameter – Qualitative test for specific pathogens (Presence/Absence of *Salmonella* & *shigella* in 10 g of sample)

**Objective, purpose & basic design of the PT scheme:**

The Objective & purpose of organizing the PT Scheme is to provide an independent assessment of performance of the participant's laboratories to produce reliable accurate and technically valid results.

**Criteria to be met for participation:**

- All the analytical drugs & pharmaceutical testing laboratories.
- Both accredited and non-accredited participants are eligible for participation in this PT round.

**Criteria for determining assigned value and the evaluation of performance:**

The evaluation of the participants performance is to done by comparing the participants result with assigned value and SDPA determined by the use of results reported by the participants labs using consensus value approach (Algorithm A as per ISO 13528).

**Confidentiality:**

- Identification of participants is kept confidential by unique coding and is known only to PT coordinator of that PT Round. PT Provider undertake its activities impartially and is committed to impartiality.
- All information provided by a participant to the PTP shall be treated as confidential.
- When PT provider is required by law or authorized by contractual arrangements to release confidential information, participant concerned is notified of the information released, unless prohibited by law and information shall be accessible to organization providing recognition & regulators.
